### CONTRACT CORNER

## Are you taking your prep time? With all the demands on our time...it's easy to

#### work right through your contract guaranteed Preparation time. This is your time!

<u>Secondary Teachers:</u> A minimum of five minutes of preparation time shall be provided within the student day for every twenty-five minutes of instruction time. Preparation time shall be provided in one or two uninterrupted blocks during the student day, one of which must be a minimum of 40 minutes, unless modified by mutual consent.

<u>Elementary Teachers:</u> A minimum of five minutes of preparation time shall be provided for every 25 minutes of instruction time in one or two uninterrupted blocks. Elementary teachers shall be provided a minimum of 175 minutes of uninterrupted preparation time per week within the student schedule day. Included in the 175 minutes there shall be a minimum of one 25-minute uninterrupted block per day with the student schedule day unless modified by mutual consent.

Attending a meeting during your prep time is NOT prep time...it's a meeting.
