CONTRACT CORNER

Did you know there are two kinds of Personal Leaves? Specified and Unspecified. One of them costs you money to cover the sub pay and one doesn't. Which is which?

Section 5. Personal Leave

Staff members often are confused between General (specified) and Unspecified Leave. Keep in mind the days all come out of the same pot (sick time) but only the General Leave requires a specific reason for the leave. The contract states, "personal and family emergencies, deaths, funerals, bereavements, weddings, relocating ones residence, court appearances, estate settlements, insurance settlements, financial or business affairs that cannot be scheduled outside school hours, graduations of family members, medical and legal consultations, college or university examinations, serving as an elected delegate within a recognized political party, including approved travel time."

In addition, Minnesota state law currently provides for up to sixteen (16) hours of this leave per year for a teacher to attend school conferences or classroom activities related to their own children.

This General Leave (Specified) will be deducted from sick time but will not cost the teacher money. When applying for this leave staff should be very careful about wording the request correctly and we advise asking a union representative for help in filling out the form before submitting it.

On the other hand the Unspecified Leave is quite uncomplicated. Staff is granted one day each year.

Happy New Year

The unused portion of this leave will accumulate from year to year up to a maximum of 6 days. The pay of the teacher using this leave shall be reduced by an amount equal to a day of pay for substitute services. These days may not be used immediately preceding or following a school holiday more often than once in a 2 year period. This leave may not be used during parent conference days or the first 10 days of the school year.

The form for both types of Leave can be found on SharePoint in the HR section.

Please remember: Ask for assistance from your union rep when filling out the Specified Leave form, HR is very particular when granting this type of leave. Luckily, you probably won't need help filling out the unspecified leave form because it doesn't even ask for a reason...but it will cost you the sub pay!
