### CONTRACT CORNER

#### Did you know the district provides legal insurance?

Before you talk to a lawyer make sure you have the facts from the district benefits office. This could save you lots of money!

The district provides a prepaid group legal insurance plan for all eligible teachers and their dependents. The coverage includes:

- \*Advice and Consultation: Unlimited access for all cases. Paid in full, usual and customary.
- \*Office Work: 10 hours per case paid in full.
- \*Defense Representations: 10 hours per case paid in full.
- \*Plaintiff Actions: 10 hours per case paid in full (subject to \$100 per case deductible).
- \*Litigation Expense: Paid in full to a maximum of \$2,500 per case.
- \*Survivor Benefits: In the event of death, your surviving spouse is entitled to coverage under the policy for a period of two years from the date of death.
- \*Major Trial Coverage: \$375 per day beginning with the third day of the trial up to \$10,000.
