### Contract Corner

Reminder that we have changed our Personal Leave to Discretionary Leave on a two-year Memorandum of Understanding trial period. That being said... let's all be respectful in using this gift of time.

\*Everybody still gets 12 total days at the beginning of the school year.

\*Discretionary days are based off of years of service in district 622

- a) At the start of years one through three 3 days
- b) At the start of years four through ten 5 days
- c) At the start of eleven years and beyond 7 days
- \*All remaining days and accumulated days from years past can be used for sick days, bereavement, or 16 hours a year for parent involvement in school activities.
- \*Approval of discretionary leave is subject to the following provisions:
- a) The teacher must notify the appropriate administrator a minimum of three (3) days in advance of the absence except in the case of emergency.
- b) The administrator is not obligated to grant discretionary requests of more than ten (10) percent of the teaching staff in a building.
- c) Cannot take more than five (5) consecutive days.
- d) Will not be used immediately preceding or following a school holiday or a vacation period.
- e) May not be taken in the first ten (10) day and last ten (10) days of the school year.
- f) May not be used during parent conference days
- g) Exceptions to sentences b, c, d, and e may be granted by the Director of Human Resources. The decision of the Director shall not be subject to review under the grievance procedures of the contract.

# Minnesota's quality of life compared with weak union states

Working in union gives educators the power to make meaningful improvements for students, our profession, public education and our communities. But corporate interests want to destabilize unions through so-called right-to-work legislation at the national and state levels because we are the last line of defense for the middle class. By many measures, quality of life is worse in states with right-to-work laws. Wages are lower and people are less likely to have health insurance and the necessary resources for a quality education. Here's a look at how Minnesota compares to 25 states that already have such laws on the books:

Life expectancy	81.1 yrs.	77.96 yrs.
Avg. Teacher Salary	\$56,910	\$49,358
Per-pupil expenditure	\$11,510	\$9,879
ACT Scores	23.04	21.3
SAT Scores	1107	1055
Poverty Rate	10.2%	15.26%
Unemployment Rate	3.8%	4.97%
