Contract Corner

MN Statute 181.9412 SCHOOL CONFERENCE AND ACTIVITIES LEAVE.

SUBD. 2.LEAVE OF 16 HOURS.

An employer must grant an employee leave of up to a total of 16 hours during any 12-month period to attend school conferences or school-related activities related to the employee's child, provided the conferences or school-related activities cannot be scheduled during nonwork hours. If the employee's child receives child care services as defined in section 119B.011, subdivision 7, or attends a prekindergarten regular or special education program, the employee may use the leave time provided in this section to attend a conference or activity related to the employee's child, or to observe and monitor the services or program, provided the conference, activity, or observation cannot be scheduled during nonwork hours. When the leave cannot be scheduled during nonwork hours and the need for the leave is foreseeable, the employee must provide reasonable prior notice of the leave and make a reasonable effort to schedule the leave so as not to disrupt unduly the operations of the employer.

SUBD. 3.NO PAY REQUIRED; SUB-STITUTE OF PAID LEAVE.

Nothing in this section requires that the leave be paid; except that an employee may substitute any accrued paid vacation leave or other appropriate paid leave for any part of the leave under this section.

How does this impact 622 teachers?

Prior to last school year, we had "personal days" in our contract. Our district allowed 16 hours of PAID leave for children's activities each school year. You did this by submitting for a personal day. Starting last year, we switched our personal leave language, and now we have discretionary days. You can still attend your child's school activities throughout the school year and have PAID leave. Instead of submitting for a personal day, now you submit a discretionary day.

Frequently Asked Questions:

1)What if I want to do more than 2 days of children activities?

Good news! Now you can. Prior to last year, you could only do 16 hours no matter what. Now, depending on how many discretionary days you have (3, 5, or 7), you can use all of those days. Remember, you NEVER have to give a reason for your discretionary days. But also remember, your 16 hours of children activities comes out of your discretionary time, you do not get this in addition to your discretionary days.

2) I never used to be able to do college visits with my child, can I now?

Yes, you can still use your discretionary time! Remember, you do not have to give a reason for discretionary time off. College visits, however, are not covered under the state statute.

3) What if I run out of discretionary days, can I still use time for my child's school activities?

Yes! If you were hired prior to last school year, you may have unspecified days that can still be used. Or, you can always use unpaid days. Just remember to use your discretionary days wisely and try to plan your year out the best that you can.

4) What if my child's activities falls in the first or last 10 days of school, on a day before or after a holiday, if more than 10% of my staff are out of the building, etc?

It is OK to send a quick question to our HR director and ask for it. If need additional guidance or support, you can AL-WAYS contact your union rep.
