The Basic School Day according to the contract (page 4, section 5)


The day consists of 8 hours, which includes a duty-free lunch of approximately 30 minutes, and 5 hours of student instruction and supervision. At the elementary schools, the 8 hour day also includes 5 minutes of student supervision prior to the start of the day. Seven and three fourths hours shall be determined by the principal, the other 15 minutes will be at the teacher's discretion, either before or after the seven and three fourths time block.


